## Dear Mr President,

We are very grateful for your interest in our case. Unfortunately it is once again attemted to be swept under the rag.

After a few protests of the plushes in front of the President's Palace and the General Prosecutor's Headquaters last year the investigation had been resumed in the Local Government of Lodz. This time the prosecutor decided that the offence has been committed, but no one will be prosecuted, because no one was hurt. In fact it is as if the offence has never been committed. Therefore the Prosecutor's Office is not able to stop the next eviction designated for October 18<sup>th</sup> 2018. The Foundation bears huge costs because of the Local Government's crime. The losses are estimated at 25 milion zlotys. In fact the Foundation was nearly destroyed. By evition the Local Government wants to show that the Foundation is not honest in this case.

The Foundation helps children for 20 years, organising among others winter and summer vacations, fundings for schools across the country. Until 2010 we were one of the most active and the fastest developing foundation in Poland. In 2007 the organisation moved to a new building. In 2010 we had three floors in the building by the Gdańska street in Lodz. At the first floor was the accounting, the safe and countertop. On the second floor we had the office, head office, day rooms for children and partly the hostel. On the third floor were another day-rooms and the second part of the hostel. Now we have here the office and storerooms conditionally. During a year about 2000 children had been able to benefit from it. The Foundation spent hundrets of thousands zlotys to adapt the rooms. When in 2010 we were forced to stop the statutory activity in the building the Local Government still collected a rent from us. Comparing to 2010 the Foundation's activity is ten times smaller.

The first eviction from the second floor (where used to be head office) took place on September the 9<sup>th</sup> 2016. We had a possibility to go to third floor then. The Foundation suffered great losses along with the great trauma.

The second eviction (from the first floor) is planned for October 18<sup>th</sup> 2018. We won't have any place to move to now, and it will paralize our activity.

There is a huge possibility of the third eviction from the third floor. The Local Government has a court decision to conduct the eviction. If the the Foundation would be evicted from the first and the third floor it won't keep any room to operate. This means that the Local Government is able to destroy the Foundation.

Eviction conducted by the Government of Hanna Zdanowska takes places in criminal circumstances, because the local government cheatet the Foundaion when it has given, to realize our statuory activity, rooms that could threaten people's life. Loses and devastation of the Foundation cannot be taken back. It is disgusting that a criminal and knacker – the Local Government – is trying to make Foundation look like a criminal, it beats and make it's victim suffer which is approved by the Prosecutor's Office, the institution that should protect and conduct the compensation and is approving criminal actions instead.

The Prosecutor's Office by keeping the files of that case blocked the Court, which would be able to stop eviction. The files had been borrowed for 3 days and were kept for 3 weeks. In that situation the Court has a limited ability to become familiar with the case and the eviction could be realized, which would bring another loses to the Foundation.

It would be understood that in normal situation the Prossecutor's Office should put charges. That would enable to stop the hooligan action of the Local Government against the charity organisation, that acts for children.

It is evident that pression put on the Prossecutor's Office reaches deeper. Demonstration of the criminal acts could ufold the circumstances of financial difficulties of the Foundation, which were the cause of delay in paying the tax (PIT 4). By which the president and founder of the organisation had been shown as a criminal, although considering financial difficulties of the organisation he doesn't take his salary for many years. And everything because of the fraud which brought loses in milions of zlotys to the Foundation.

The long crisis ongoing in the Foundation causes financial difficulties which also today causes difficulties with current tax fees. As a result also members of the executive board could be accused of tax evation. It might further damage the Foundation's image. This difficulties our Foundation owes the Local Government lead by Mrs President Zdanowska.

The honest inquiry and bringing charges to the guilty party would show true face of the Foundation, which today is shown as dishonest. According to that narration even the President of the Foundation was a criminal if he didn't not make sure that the taxes are paid. No one would mention the fact that this was due to situation in which the Foundation is the victim of a crime. Even the Court wasn't interested in that. Even the trial of the President of our Foundation was conducted without a attorney, though according to the Constitution it is the right of every citizen to have a lawyer. It becomes evident that the Foundation is being destroyed by a hooligan action of the people considered as honest and righteous citizens, guardians of social order and justice, occupy high offices. It shows that they act on harm of the Little Match Girl and children, victims of fate.
